THIS MORTGAGE is made this 2nd day of November
1979, between the Mortgagor, BOB MAXWELL, and the Mortgagee, First Federal
Savings and Loan Association, a corporation organized and existing under the laws of the United States
of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-one Thousand Two
Bundred and No/100 (\$51,200.00) Dollars, which indebtedness is evidenced by Borrower's
note dated November 2, 1979 (herein "Note"), providing for monthly installments of principal
and interest, with the balance of the indebtedness, if not sooner paid, due and payable on November
1, 2010.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest
thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect
the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein
contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by
Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage,
grant and convey to Lender and Lender's successors and assigns the following described property located
in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being on the
Southern side of Windward Way, in the County of Greenville, State of
South Carolina, being shown and designated as Lot No. 178 on a plat
entitled "Section No. 9, Devenger Place", prepared by Dalton & Neves Co.,
dated May, 1978, and recorded in the R.M.C. Office for Greenville County,
South Carolina, in Plat Book 6-B at page 71, and having, according to said
plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Windward Way at the joint
front corner of Lots Nos. 178 and 177, and running thence with the line of
Lot No. 177 S. 23-02 E. 147.6 feet to an iron pin; thence N. 70-28 E. 40.2
feet to an iron pin; thence N. 66-38 E. 44.8 feet to an iron pin at the
joint corner of Lot No. 178 and Lot No. 103, Section 4; thence with the
line of Lot No. 103, Section 4, N. 23-02 W. 150 feet to an iron pin on the
Southern side of Windward Way; thence with the Southern side of Windward
Way S. 66-38 W. 85 feet to the point of beginning.
