WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **FORTY-SEVEN THOUSAND SEVEN HUNDRED AND NO/100 DOLLARS**

(\$ 47,700.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable at therein stated or as modified by mutual agreement, in writing, the final maturity of which is **30** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or reckoned to be for the Mortgagor's account, including advances made by the Mortgagee on other or no security;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 124 on a plat of Pine Brook Forest Subdivision according to a plat prepared by Charles K. Dunn, Surveyor, said plat being recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4 X at pages 48 and 49 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Cannon Circle joint front corner of Lots Nos. 123 & 124; running thence down the line of said lots S. 06-27 W. 200 ft. to an iron pin; running thence N. 83-33 W. 137 ft. to an iron pin; running thence N. 71-51 E. 51.8 ft to an iron pin at the corner of Lot No. 125; running thence up the joint line of Lots Nos. 124 and 125 N. 06-27 E. 150 feet to an iron pin on the southern side of Cannon Circle; running thence down the southern side of Cannon Circle S. 83-33 E. 125 ft. to the point of beginning.
