Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand Five Hundred Fifty and No/100 Dollars (\$9,550.00), with interest from date at the rate of Four & One Half per centum (4 1/2%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty Three and 09/100 Dollars (\$53.99), commencing on the first day of June, 1955, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 1960.

All that lot of land with the buildings and improvements thereon, situate on the Southwest side of Andrews Street (formerly known as Poplar Street), near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 9 on Map No. 6 of Property of Valmer Corbell, made by Dalton & Neves, Engineers, January 1951, recorded in the R. M. Office for Greenville County, S. C., in Plat Book "2", at page 151, said lot fronting 63 feet along the Southwest side of Andrews Street, running back to a depth of 160 feet on the Northwest side, to a depth of 162.3 feet on the Southeast side of said lot along Bel Aire Drive, and being 90.5 feet across the rear.
