MORTGAGE

THIS MORTGAGE is made this 15th day of October,
1979, between the Mortgagor, Gatewood Builders, Inc.,

(herein "Borrower"), and the Mortgagee, First Federal
Savings and Loan Association, a corporation organized and existing under the laws of the United States
of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-Five Thousand Nine
Hundred Fifty and No/100 (\$55,950.00) -- Dollars, which indebtedness is evidenced by Borrower's
note dated October 15, 1979, (herein "Note"), providing for monthly installments of principal
and interest, with the balance of the indebtedness, if not sooner paid, due and payable on
October 1, 2010.;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest
thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect
the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein
contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by
Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage,
grant and convey to Lender and Lender's successors and assigns, the following described property located
in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being on the Southern
side of Canebrake Drive, near the City of Greenville, in the County of Green-
ville, State of South Carolina, and known and designated as Lot No. 150 of a
Subdivision known as Canebrake, Phase I, plat of which is recorded in the R.M.C.
Office for Greenville County in Plat Book 7-C at Page 16, and, according to
said Plat, has the following lines and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Canebrake Drive at the joint
front corner of Lots Nos. 149 and 150, and running thence with the Southern
side of said Drive N. 33-26 E. 59 feet to an iron pin; running thence S. 29-45 E.
138.16 feet to an iron pin; running thence S. 55-41 W. 59 feet to an iron pin
at the joint corner of Lots Nos. 150 and 148; running thence with the joint
line of Lots Nos. 150, 148 and 149 N. 29-36 E. 134.68 feet to an iron pin on [redacted]
the Southern side of Canebrake Drive, point of beginning.
