All that certain piece, part of or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 67 on a plat of the property of Map No. 2, Cherokee Forest, recorded in Plat Book 32 at pages 192-193 in the Plat Office for Greenville County and having according to said plat the following lines and bounds, to-wit:

BEGINNING at an iron pin on the North east side of Cherokee Drive at the joint front corner of lots 67 and 68 and running thence with the line of Lot 68, N. 56-30 E. 175.2 feet to an iron pin; thence along the line of Lot 68, S. 32-30 E. 102 feet to an iron pin on Gail Avenue; thence with Gail Avenue, S. 32-30 W. 151.4 feet to an iron pin at curve of intersection of Gail Avenue, and Cherokee Drive; thence with the curve of the intersection of Gail Avenue and Cherokee Drive, N. 78-37 W. 35.3 feet to an iron pin on Cherokee Drive; thence with said Cherokee Drive, N. 32-30 W. 75 feet to the beginning corner.
