THIS MORTGAGE is made this 12th day of May, 1978, between the Mortgagor, Danco, Inc.,

, (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender"). W/BS/11

WHEREAS, Borrower is indebted to J. J. G. in the principal sum of Fifty-seven Thousand Five Hundred and No/100 (\$57,200.00) Dollars or so much thereof as may be advanced, which indebtedness is evidenced by Borrower's note dated May 12, 1978 (herein "Note"),
