NOT KNOW ALL MEN, that the mortgagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Consumer Credit Contract, which with all its provisions is hereby made a part hereof, and also in consideration of their bills as to the said mortgage in hand well and truly paid, by the said mortgagor, do hereby acknowledge the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said mortgagor, its (his) heirs, successors and assigns forever, the following described real estate:

Hickey, 1968, recorded in the L.M.C. Office for Greenville County, South Carolina, by Book 117 at page 419, and having according to said plat the following notes and bearings: Beginning at an iron pin on the southern side of Lermann Drive at the front right corner of Lot No. 19 and 20, and thence thence with the east of Lot No. 19 S. 2-25 W. 125.5 feet to an iron pin thence with the east of property and in vicinity of W.A. As a part of the consideration for this conveyance the Grantor herein agreed and agreed to pay the balance due on a certain note and mortgage from Billy Martin and Patsy C. Martin to Carolina Federal Savings and Loan Association of Greenville dated June 24, 1959 and recorded in said L.M.C. Office in Book Page 233, at page 577, principal balance \$7,339.13.
