THIS MORTGAGE is made this 19 79, between the Mortgagor, WILLIAM R. FAIRBANKS

(herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of NINETY-NINE THOUSAND NINE HUNDRED FIFTY AND NO/100 (\$99,550.00) Dollars, which indebtedness is evidenced by Borrower's note dated April 5, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 1, 2009.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereto (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 7 on plat prepared for Mr. Rick Fairbanks by Arbor Engineering, dated July 10, 1978 and amended February 13, 1979, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 6-N at page 96, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point on the edge of an unnamed road and running thence along the line of Lots 7A and 7, S. 58-26-31 E. 270.54 feet; thence running N. 03-42-14 W. 75.21 feet to an iron pin; thence running N. 09-43-56 E. 91.32 feet to an iron pin; thence running N. 23-26-31 W. 235.65 feet to an iron pin at the joint corner of Lots 7 and 6; thence running along line of said lots N. 58-03-07 E. 320 feet to an iron pin; thence running along the eastern line of Lot No. 7 S. 14-38-42 E. 702.92 feet to an iron pin; thence running S. 14-42-44 E. 177 feet to an iron pin; thence running S. 53-46-46 W. 222.77 feet to an iron pin; thence running S. 35-43-56 W. 92.76 feet to an iron pin; thence running S. 35-45-56 W. 23.00 feet to the joint corner of Lots No. 8 and No. 7; thence running along the line of said lots N. 76-46-49 W. 94.78 feet to an iron pin; thence running N. 66-53-14 W. 156.01 feet to an iron pin; thence running with unnamed road N. 35-10-24 W. 82.91 feet to an iron pin; thence running N. 37-39-14 W. 83.73 to an iron pin; thence running N. 01-43-56 E. 131.70 feet to an iron pin; thence running N. 69-34-44 W. 75.26 feet to an iron pin, the point of BEGINNING.
