NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the abovesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Roxbury Terrace in the City of Greenville, being shown and designated as Lot No. 3 on the plat of property of E. M. West recorded in Plat Book FFF at Page 157, and having according to said plat the following notes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Roxbury Terrace at the joint front corner of Lots Nos. 2 and 3 and running thence with the Northern side of Roxbury Terrace, the following courses and distances: S. 60-05 W. 16.5 feet; thence continuing S. 69-17 W. 140 feet; thence S. 61-04 W. 14.5 feet to pin; thence N. 21-13 W. 44 feet to pin; thence N. 38 E. 26 feet; thence N. 28-32 E. 73 feet to pin; thence with the branch as the line, the chord of which is N. 50-33 E. 45.4 feet to pin at rear corner of Lot No. 2; thence with line of Lot No. 2, S. 34-17 E. 175.5 feet to the point of beginning.
