JAMES A. GODFREY AND DENEAR M. GODFREY

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Twelve Thousand and No/100 DOLLARS (\$ 12,000.00)**, with interest thereon from date at the rate of **5 1/2 per centum per annum**, and principal and interest to be repaid in monthly installments of **Seventy-Four & No/100 Dollars (\$ 74.00)** each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

"All that certain piece, part of lot of land, with all improvements thereon, so hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, on the northern side of Northside Circle, shown as Lot No. 30 on plat of Northside Heights, recorded in Plat Book MM at Page 89 in the R.M.C. Office for Greenville County, and being more particularly described by metes and bounds, as follows:

"BEGINNING at an iron pin on the northern side of Northside Circle, at the corner of Lots Nos. 30 and 31, and running thence along the joint line of said lots, N. 10-35 W. 70 feet to pin, corner of Lot 29; thence along the line of Lot 29, N. 78-01 E. 162.5 feet to pin on the western side of Short Street; thence along the western side of said Street, S. 02-41 E. 17.4 feet to pin, at the curve of the northwestern corner of the intersection of Short Street and Northside Circle; thence along the said Curve, the chord of which is S. 43-56 W. 77.5 feet to iron pin on the northern side of Northside Circle; thence along said Northside Circle S. 95-37 W. 73 feet to iron pin; thence continuing along Northside Circle, S. 74-47 W. 52.5 feet to the beginning corner."
