WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-one Thousand Five Hundred and no/100-----DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 25 on a revised plat of Burdette Estates, prepared by Dalton & Neves, dated December 10, 1973, recorded in Plat Book 5-D & Page 71 and being described, according to said plat, more particularly to-wit:

BEGINNING At an iron pin on the northern side of Oak Park Drive at the joint front corner of Lots 25 and 26 and running thence along the northern line of said drive, N. 31-16 W. 104.8 feet to an iron pin at the intersection of Oak Park Drive and Barrett Drive; thence N. 33-30 W. 33 feet to an iron pin on the eastern side of Barrett Drive; thence N. 14-16 E. 135 feet to an iron pin at the joint front corner of Lots 25 and 45; thence along the common line of said lots, S. 78-56 E. 113.9 feet to an iron pin at the joint rear corner of said lots; thence along the common line of Lots 25 and 26, S. 8-44 W. 154.1 feet to an iron pin, the point of beginning.
