WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty Three Thousand Two Hundred

DOLLARS (\$ 43,200.00) JUN 27 1973 with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the northeastern side of Woodruff Road, in Austin Township, Greenville County, State of South Carolina, containing 5.17 acres, and being a portion of that property shown on a plat entitled Property of Michael F. Jaslich and Cynthia S. Jaslich, recorded in the RIC Office for Greenville County, South Carolina in Plat Book 5-C, Page 51, and being more particularly described according to a plat entitled Property of Dr. John M. Warren, Jr., made by Gould & Assoc., Surveyors, dated 2/21/77 and having according to said plat the following metes and bounds:
