All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Graceland Cemetery and having the following metes and bounds:

COMMENCING at an iron pin on the South side of right of way on the new State Highway leading to Easley and on line of property of now or formerly Sallie Scott; thence along the South right of way of Easley Highway N. 71-20 W. 55 ft. to an iron pin; thence along the line of property now or formerly Minnie Mack S. 3-55 E. 163.1 ft. to an iron pin; thence continuing with same property along rear S. 71-20 E. 91 feet to an iron pin on line of property of now or formerly Sallie Scott; thence along line of this property of now or formerly Sallie Scott; thence along line of this property N. 14-30 W. 180 ft. to the point of beginning, same containing 1/4 acre more or less, Surveyed February 23, 1929 By R.
