THIS MORTGAGE, dated first day of April 1, 1980, between the Mortgagor, B & W Aerials, Inc., (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

Witness, Borrower is indebted to Lender in the principal sum of **L**efty-Nine Thousand One Hundred and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated April 1, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 1, 2010.

All that piece, parcel or lot of land situate, lying and being in the Town of Mauldin, County of Greenville, State of South Carolina, on the northern side of Gail Drive and being known and designated as Lot 52, on plat of Map No. 1 SECTION 5 of HOLLYWOOD HEIGHTS, recorded in the R.N.C. Office for Greenville County, South Carolina, in Plat Book 4R at Page 91 and being more fully described according to a plat of "Property of B & W Aerials, Inc.", dated March 26, 1980, prepared by Carolina Surveying Co., as follows:

Beginning at a point on the northern side of Gail Drive at the joint front corner of Lots 52 and 53 and running thence along a line of Lot 53, N. 02-10-28 W., 165 feet to a point; thence along lines of Lots 59 and 70 N. 87-49-32 E., 135 feet to a point; thence along a line of Lot 51, S. 02-10-28 E., 165 feet to a point on the northern edge of Gail Drive; thence along the northern edge of Gail Drive S. 87-49-32 W., 135 feet to the beginning corner, and being the same property conveyed to B & W Aerials, Inc. by a deed from Frank P. McGowan, Jr., Master for Greenville County, dated this date and recorded herewith.
