WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Eleven Thousand Five Hundred and no/100 DOLLARS (\$ 11,500.00), with interest thereon from date at the rate of Five and one-half per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor is hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot 8, as shown on a plat of the property of M. J. Howell, prepared by W. J. Hines, March, 1914, recorded in Plat Book C at page 155, and being more particularly described according to said plat as follows:

BEGINNING at an iron pin on the Western side of E. North Street Ext. at the joint front corner of Lots 7 and 8, and running thence with E. North St. Ext., N. 11° E. 74 feet to an iron pin; thence N. 22 $\frac{1}{2}$ W. 225 feet to an iron pin; thence S. 62 $\frac{1}{2}$ W. 33 feet to an iron pin; thence S. 32 $\frac{1}{2}$ W. 41 feet to a point in Rickland Creek; thence with said Creek, S. 9° E. 22 $\frac{1}{2}$ to a point in Rickland Creek; the joint line of the corner of lots 7 and 8; thence with joint line of said lots, S. 85 $\frac{1}{2}$ E. 251 feet to an iron pin on the Western side of E. North Street, Ext., the point of beginning.

Being the same property conveyed to Mortgagor by deed recorded in Deed Book 431 at page 120.

The above premises is subject to a sewer right-of-way agreement to the Greater Greenville Sewer District Commission recorded in Vol. 436 at page 529.

LESS HOWEVER: That portion of said Lot No. 8 shown on plat recorded in the R. V. C. Office for Greenville County in Plat Book "M" at page 150, heretofore conveyed by the mortgagor to Walter S. Griffin, and being the Western portion of Lot No. 8. See deed recorded in the R. V. C. Office for Greenville County in Deed Book 569, at page 135.
