THIS MORTGAGE is made this 1st day of November, 1979,
19..., between the Mortgagor, ELMER S. WILSON, INC., (herein "Borrower"), and the Mortgagee, Family Federal
Savings & Loan Association, a corporation organized and existing

Greer, South Carolina (herein "Lender").
