THIS MORTGAGE is made this 1st day of 1979, between the Mortgagor, M. Rhett Thackston and Sherry A. Thackston (herein "Borrower"), and the Mortgagee, FIDELITY FEDERAL SAVINGS AND LOANS ASSOCIATION, under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty Thousand and No/100 (\$50,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated October 1, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on March 1, 2010.
