BEGINNING at a point in the center of a branch at the joint rear corner of lots Nos. 35 and 36 and running thence with the center of said branch in a northeasterly direction the chord of which is S. 4-05 E., 72 feet to an iron pin; running therewith the line of lot No. 35, N. 43-21 W., 20 feet to a bend in line; thence in a northwesterly direction 70 feet, more or less, to an iron pin in the center of a branch at the joint ^{northeast} corner of lots Nos. 35 and 36, of beginning.

ALSO: All that lot of land in Greenville County, State of South Carolina, in the northeastern corner of the intersection of Lowndes Hill Road with Arbutus Trail being known and designated as Lot No. 35 on a plat of Ellenton Acres Section A prepared by Woodall Engineering Company dated September, 1955, recorded in Plat Book EE at Page 161 and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the western side of Arbutus Trail, near the intersection of said street with Lowndes Hill Road and running thence with Arbutus Trail, S. 1-39 W., 95 feet to an iron pin at the front corner of lot No. 35; thence with the line of said lot, S. 83-21 W., 161 feet to an iron pin, near the southern side of a creek; thence with the creek as the line, the traverse of which is S. 4-05 E., 72 feet to a point; corner of Clark property; thence with the line of said property, S. 86-0 E., 87.3 feet to a point; thence continuing with the line of said property, S. 67-0 E., 55 feet to a point on the northern side of Lowndes Hill Road; thence with the northern side of said road, N. 83-37 E., 20 feet to a point at the corner of the intersection of said road with Arbutus Trail; thence with the curve of said intersection, the traverse of which is N. 43-21 E., 35.4 feet to the point of beginning. —Continued on reverse side
