THIS MORTGAGE SECURES FUTURE ADVANCES - MAXIMUM OUTSTANDING \$100,000.00

WHEREAS, Lillie C. Williams and Barbara Adams (hereinafter referred to as Mortgagor) is well and truly indebted unto NCC Financial Services, Inc. #38, P.O. Box 2852, Greenville, S.C. 29602, its successors and assigns forever (hereinafter referred to as Mortgagee) as evidenced by the Mortgage's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four thousand two hundred and 00/100----- Dollars (\$ 4,200.00) due and payable

in monthly installments of \$ 70.00, the first installment becoming due and payable on the 20th day of November, 1976 and a like installment becoming due and payable on the same day of each successive month thereafter until the entire indebtedness has been paid, with interest thereon from maturity at the rate of seven per centum per annum, to be paid on demand.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums and other obligations for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, to sit in the city of Greenville, situate, lying and being on the East side of James Alley and being known and designated as Lot No. 4 according to a subdivision and plat of said property made by C. M. Furman, Jr., C. E., February 27, 1932, and having the following metes and bounds as shown by said plat, to-wit:

BEGINNING at a point on the East side of Jones Alley, corner of lot Number 3 and x running thence along the line of said lot S.73-52 E. 94.4 feet to the joint rear corner of lots 1 and 2; thence along the rear line of Lot No. 2, S. 20-27 W. 43 feet; thence N. 73-52 W. 93 feet to point in line of Jones Alley; thence along the line of said Alley N. 18-35 E. 43 feet to the beginning corner. This is the same property as conveyed to the Mortgagor by Will of Will A. Williams in Apt. 54 File 36, in the Probate Court for Greenville County.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

Together with all and singular rights, members, instruments, and appurtenances to the same belonging in any way incident thereto pertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fixed thereto in any manner, without the obligation of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.


