NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time he advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the accept whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

All that certain piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, which lies and is in the State of South Carolina, County of Greenville, designated as lots 21 and 22 in section 10 of the property known as Moodville Heights on plat made by W. J. Riddle, Surveyor, December, 1940, and recorded in Platbook L, pages 11 and 12, RMC Office for Greenville County, South Carolina, and more particularly described according to said plat as follows:

BEGINNING on the northside of McDoyle Street at right corner of lots 20 and 21, thence N 45-12 W., 100 feet along line of lot 20 to rear corner thereof at branch point in westerly direction with said branch as the line to the rear line of lot 22; thence along the plat line to the northwest corner of lot 22, thence S. 44-12 E., 437 feet along westerly side of lot 22 to front corner thereon on McDowell Street, thence N 68-56 E., 133-6 feet to McDoyle Street to right of beginning.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as the southern part of lots 49 and 50, was shown on plat of Junction Heights, which is recorded in the RMC Office for Greenville County in platbook C, page 106, and having the following metes and bounds, to wit:

BEGINNING at a stake at the joint rear corner of lots 49 and 50 and running thence S 12 W. 150 feet to stake at joint rear corner of lots 48 and 47; thence N 37 W., 95 feet to stake; thence N 62-30 E., 100 feet to the beginning corner.
