Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and —of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter gattached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the historial household furniture, be considered a part of the real estate.
