THIS MORTGAGE is made this 9th day of March
1977, between the Mortgagor, Barry W. McPeak and Jacalyn McPeak
..... (herein "Borrower"), and the Mortgagee, Carolina Federal
Savings and Loan Association a corporation organized and existing
under the laws of the State of South Carolina whose address is 500 E. Washington
Street, Greenville, South Carolina (herein "Lender").

Office for Greenville County, South Carolina, in Plat Book QQ, page 108, and having according to said plat the following metes and bounds, to-wit:
