R.M.C. MORTGAGE

THIS MORTGAGE is made this 18th day of *January*, 1989, between the Mortgagor, *Gatewood Builders, Inc.* (herein "Borrower"), and the Mortgagee, *FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION*, a corporation organized under the laws of *SOUTH CAROLINA* whose address is *101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA* (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of *Eighty Thousand Eight Hundred Dollars*, and No/100 (\$80,800.00) Dollars, which indebtedness is evidenced by Borrower's note dated *August 18, 1982* (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on *March 1, 1982*.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of *Greenville*, State of South Carolina:

ALL that place, parcel or lot of land situate, lying and being on the Northeastern side of Gathburg Square, near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 37 of a Subdivision known as Eastgate Village, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 4-X at Page 31, and, according to said plat, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Gathburg Square, at the joint front corner of Lots Nos. 36 and 37, and running thence with the joint line of said lots N. 47-52 E. 129 feet; running thence S. 36-20 E. 32.1 feet to an iron pin at the joint rear corner of lots Nos. 37 and 39; running thence with the joint line of Lots Nos. 37, 39 and 38 S. 34-55 W. 140.65 feet to an iron pin on the Northeastern side of Gathburg Square; running thence with said Square N. 23-13 W. 51.3 feet to an iron pin; thence continuing with said Square S. 30-25 W. 6 feet to an iron pin, point of beginning.
