MORTGAGE

50. THIS MORTGAGE is made this 18th day of March 1981, between the Mortgagor, COTHRAN & DARBY BUILDERS, INC., and the Borrower, CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of South Carolina, whose address is Post Office Box 10148, Greenville, South Carolina 29603 (in "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Sixty Four Thousand Three Hundred and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated March 18, 1981 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on March 18, 1982.
