Office of Greenville County, South Carolina, in Plat Book 14, at Page 333 and having, according to said plat, the following lines and bounds, to wit:

~~RECORDING~~ at a point on the northern side of Old Spartanburg Road, at the joint front corner of Lots Nos. 122 and 123 containing hence E. 06-53 W., 200 feet to a point at the joint front corner of Lots Nos. 122 and 123; thence S. 83-07 W., 99.6 feet to a point on the eastern side of Beaufort Street at the joint corner of Lots Nos. 123 and 124; thence with the eastern side of Beaufort Street S. 15-37 W., 65.7 feet to a point; thence continuing with the eastern side of Beaufort Street S. 07-12 W., 72.8 feet to a point, thence still continuing with the eastern side of Beaufort Street, S. 06-53 E., 35 feet to a point; thence following the curvature of the northeastern intersection of Beaufort Street with the Old Spartanburg Road, the chord of which is S. 51-53 E., 21.2 feet to a point; thence with the Northern side of Old Spartanburg Road, N. 83-07 E., 135 feet to the point of beginning.
