MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Wilma L. King and Alec G. King

(hereinafter referred to as Mortgagors) is well and truly indebted unto W. Smith Batson and Edna M. Batson

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagee's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand and 00/100-----

Dollars (\$ 6,000.00 ) due and payable

in installments of Five Hundred and 00/100 (\$500.00) Dollars quarterly beginning Ninety (90) days from date and a like amount each Ninety (90) days thereafter until Two (2) years from date at which time the entire balance shall become due and payable, payment to apply first to interest and balance to principal, with privilege of anticipation in whole or in part at any time with interest thence from date at the rate of Ten per centum per annum, to be paid quarterly

NOTE, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 8 on plat of The FOUR Seasons Subdivision, plat of which is recorded in Plat Book 4-R, at Page 46, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point on the northwesterly side of Fairway Lane at joint front corner of Lots Nos. 8 and 9 and running thence with the line of said lots N. 46-28 W., 260 feet; thence N. 38-39 E., 100.4 feet; thence S. 46-29 E., 268.3 feet to a point on Fairway Lane; thence with Fairway Lane S. 43-21 W., 100 feet to the point of beginning.
