WHEREAS, Mortgagor is indebted to Mortgagee for money loaned, to secure the payment of which Mortgagor has executed and delivered to Mortgagee a note of even date herewith, in the principal sum of **Twelve thousand Seven**

ALL that lot of land with the buildings and improvements thereon, situate on the Southwest side of Richbourg Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 19 on plat of Morningside Subdivision made by Dalton & Neves, Engineers, in December, 1952, recorded in the SMC Office for Greenville County, S. C., in Plat Book "EE", pages 2 and 3; said lot fronting 125 feet along the Southwest side of Richbourg Road, running back to a depth of 200 feet on the Southeast side, to a depth of 200 feet on the Northwest side, and being 125 feet across the rear.


