## MORTGAGE

COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: THE DOUGLAS CO.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-Four Thousand and 00/100

DOLLARS (\$ 34,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in Greenville County, State of South Carolina, known as Lot # 7,

Section I, Westminster Village, as shown in Plat made by W. Carroll Inabinet, R. E., 4/15/76 and recorded in the R. M. C. Office of Greenville County in Plat Book 5P at Page 102 on 8/3/76, and having the following

dimensions and bounds, to-wit:
