WHEREAS, Charles J. Kirell and Sharon L. Kirell

(hereinafter referred to as Mortgagor) is well and truly indebted unto Nelle H. Cowan

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand and No/100 (\$12,000.00) -----

----- Dollars XXXXXXXXXXXXX due and payable in the following manner: One hundred and forty-six and 60/100 (\$126.60) dollars shall be paid on the first day of January, 1973, and a like amount shall be paid on the same date of each succeeding month until the principal balance, together with interest, shall be paid in full, with interest thereon from date July 1, 1972 per centum per annum, to be paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be liable to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

"ALL that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the western side of Robinson Street and being known and designated as Lot "E" on a plat of the property of H. J. Martin, prepared by Dalton & Neves, Engineers, December, 1929, and recorded in the R.P.C. Office for Greenville County, South Carolina, in Plat Book 1, at Page 255, and according to said plat, having the following courses and distances:

BEGINNING at an iron pin on the western side of Robinson Street, 100 feet south of Randolph Street, joint front corner of Lot "D" and running thence with the line of said lot, N. 85-00 W. 130 feet to an iron pin on line of Lot "G", thence with the line of said lot "B", S. 2-20 W. 48.6 feet to an iron pin on line of lot conveyed by Stella D. Stone to Lonibel Oeland; thence, with Oeland's line S. 44-55 E. 130 feet to an iron pin on Randolph Street; thence running with said street, N. 2-20 E. 48.4 feet to the beginning corner.
