To All Whom These Presents May Concern:

WILLIE JERRY CANTRELL AND SHARON GAIL CANTRELL

(Benevolent referred to as Venerable) (SESPNS) GREETINGS.

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagor) in the full and just sum of TWENTY THOUSAND SIX HUNDRED FIFTY AND NO/100 ----- (\$20,650.00)

Dollars as evidenced by Mortgagor's promissory note of even date herewith, which note provides for an escalation of interest rate under certain provisions for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest at the rate or rates thereto specified in installments of ONE HUNDRED FORTY SEVEN AND 95/100 ----- (\$147.95) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagor, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and such holder shall have the right to institute any proceedings upon said note and any collateral given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;




That the Mortgagor, in consideration of said date and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released and by these presents does grant, bargain, sell and release unto the Mortgagor its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situated, lying and being in the State of South Carolina, County of **Greenville**, **Fairview Township** having the following rates and bounds, to wit:

BEGINNING at a stone in the old road bed, road which formerly led from Fountain Inn to Neely-Ferry Road by via of Hammond place, on line of land formerly belonging to H. Y. Boyd, and running thence along said old Road bed, S. 61-45 W. 250.8 feet to a point in said old road bed; thence S. 27-30 W. along the old road bed, 59.4 feet to a point; thence continuing with said creek in a northerly direction 280 feet, more or less, to a point; thence in an easterly direction along new road 360 feet to a point on line of land formerly belonging to H. Y. Boyd; thence with the joint line of the formerly Boyd property, S. 3-15 W. 276 feet to the point of beginning; and bounded by lands formerly belonging to H. Y. Boyd an old abandoned road bed, creek and others.
