WHEREAS, Willie Green (hereinafter referred to as Mortgagor) is well and truly indebted unto NCC Financial Services, Inc., 123 W. Antrim Dr., Greenville, S. C. its successors and assigns forever (hereinafter referred to as Mortgagee) as evidenced by the Mortgage's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Thousand Five Hundred Eighty Dollars & 32/100 Dollars (\$ 15,580.32) due and payable in monthly installments of \$ 185.48, the first installment becoming due and payable on the 15th day of July 77 and a like installment becoming due and payable on the same day of each successive month thereafter until the entire indebtedness has been paid, with interest thereon from maturity at the rate of seven per centum per annum, to be paid on demand.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagor for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes; *Excluded*

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums and other obligations for which the Mortgage may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, the Maximum Outstanding at any given time not to exceed said amount, stated above, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents doth grant, bargain, sell and release unto the Mortgagor, its successors and assigns,

ALL that certain piece, parcel or lot of land, ~~hereinafter~~ ^(S) described ~~herein~~, or hereafter contracted therefor, situate, lying and being in the State of South Carolina, County of Greenville, ^(C) having an area of ^(C) acres, more or less, bounded as follows: ^(C)

Being on the southeasterly side of Boline Street, being the property designated as lots 24, 25, and 26 on plat of property of William Richardson, et al., of Marion, Indiana, dated May 20, 1960 by J. Mac Richardson and others, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the southeastern side of Boling Circle, joint from corner of Lots Nos. 22 and 23, and running thence N. 41-54 E. 50 feet to a point; thence continuing along said Boling Circle N. 33-10 E. 50 feet to a point; thence running along the joint line of Lots Nos. 26 and 27, S. 51-50 E. 100 feet to a point; thence running S. 33-10 W. 50 feet to an old iron pin in root of 43 inch oak; thence running S. 33-10 W. 64.5 feet to a point; thence running N. 44-08 W. 104.9 feet to the point of beginning.
