Without the prior written consent of Bank, to refrain from creating or permitting any lies or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 1. The property referred to by this agreement is described as follows: All that certain piece, parcel, or lot of land situate, lying and being in Chick Springs Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 19 on plat of Property of N. A. Hack and Gladys Greene Hack, made by W. J. Riddle, March, 1941, recorded in the RMC Office for Greenville County, S. C., in Plat Book "L", at Page 35, and having the following metes and bounds, to wit:

BEGINNING at a point on the east side of Emma Street, joint front corners of Lots Nos. 18 and 19, and running thence with Emma Street N. 2-30 W. 100 feet to Lot No. 20; thence with line of said lot, N. 85-30 E. 300 feet to point in line of Lot No. 37; thence S. 2-30 E. 100 feet; thence S. 85-30 W. 300 feet to the point of BEGINNING.
