That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Association, when due, Association, at its election may declare the entire remaining unpaid principal and interest of any obligation or indebtedness the remaining unpaid to Association to be due and payable forthwith. 5.
