MORTGAGE

THE MORTGAGE is made this 30th day of April 1982, by the Borrower, EDWARD N. BARNES and SUSAN J. BARNES (herein "Borrower"), and the Mortgagee, CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of South Carolina, whose address is Greenville, South Carolina (herein "Lender").
