WHEREAS, C.D. Nesbitt and W.P. Nesbitt, did heretofore execute unto Fork Shoals Cotton Mill a deed dated February 1, 1900, recorded in R.M.C. office for said County in Book GGG, page 197; and WHEREAS, there was omitted from the habendum clause of said deed the word "Successors", and it is desired to correct said omission:

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That we, C.D. Nesbitt and W.P. Nesbitt in consideration of the premises and of the sum of One Dollar, to us in hand paid, the receipt whereof is hereby acknowledged, have granted, sold and released and by these presents do grant, bargain, sell and release unto the said Fork Shoals Cotton Mill, all our right, title and privilege, to, in and on the Jenkins tract of land heretofore belonging to J.P. Latimer in the County and State aforesaid, containing 208.75 acres, more or less, said lands as described in said deed being bounded by lands of Henry Smith, G.W. Sullivan, B.M. McGee, D.B. Jenkins, Reedy River. The said rights and privileges being those conveyed to us by deed from J.H. Latimer bearing date January 11, 1889, to which reference is made.

TOGETHER with all and singular the rights, members and hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD ALL and singular the said premises before mentioned unto the said Fork Shoals Cotton Mill, its successors and assigns forever.
