

Upon such failure of the party of the second part to make said monthly payments and to carry out the terms of this agreement as to payments, then the parties of the first part shall have the right to enter the said premises and repossess themselves, and may eject the party of the second part as a tenant holding over after the expiration of his lease and for non payment of rent. 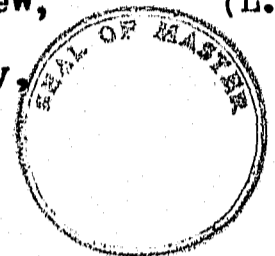

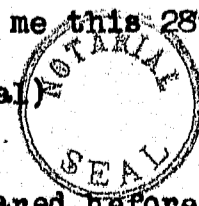
