NOW, THEREFORE, Know all men by these Presents, that I, E. Inman, Master in and for County of Greenville, aforesaid, in consideration of the sum of Fifteen Hundred Forty (\$1540.00) Dollars, to me paid by the said Enoch Howell

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said Enoch Howell, the following described real estate:

"All that certain piece, parcel and lot of land situated in Greenville County, State of South Carolina, and on the North side of the Saluda Gap Road and being a part of the real estate formerly owned by William Bomar and also a part of what is known as the Goodlett Tract and more particularly described as follows; to-wit: Beginning at an iron pin in the Saluda Gap Road and running thence N. 12 1/2 E. 24.00 to an iron pin; thence N. 85 W. 25.64 to an iron pin; thence S. 3 1/2 E. 12.83 to an iron pin; thence S. 60 E. 19.00 to an iron pin; thence S. 41-3/4 E. 4.60 to an iron pin; at the beginning corner in said Saluda Gap Road and being known and designated as Tract No.2 of the estate of I. 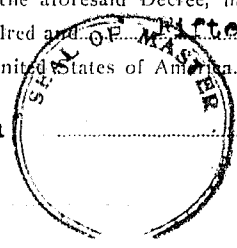
TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said Enoch Howell, his
