the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said J. H. Farmer, the following described real estate:

"All that certain parcel and tract of land situate, lying and being in the County and State aforesaid and being the same tract of land conveyed to Martha Sloan Neal by William Gryce during the year 1910, and being known as the Neal home place and bounded by J. F. Ballenger, Few and others, and containing about Twenty-five and three-fourths (25-3/4) acres, more or less."
