in the State aforesaid
in consideration of the sum of Eight hundred DOLLARS,
to me in hand paid at and before the sealing of these presents by J.T. Prewett

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.T. Prewett, All that tract or parcel of land situate, lying and being in the aforesaid State and County. Beginning on stone 3X on North side of road NM, thence with old Glassy Mountain Road to a pine in fork of old road, gone, thence S. 7 E. 10.34 R.O. 3XOM, thence S. 20 E. 11.50 R.O. 3XOM (gone) B. Gum instead, thence S. 45 E. 10.50 stake 3X in branch, thence N. 77 1/4 E. 12.50 chest. OM gone, thence S. 83 E. 12.70 to stake 3XNM, thence N. 11 E. 27.00 on line of tract No. 2 to beginning corner, containing ninety nine and one-half acres, more or less. This being to land deeded to me and on record in Book R.R.R. page 649, Feby. 23, 1906.
