is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

J. K. Huff, a certain tract or lot of land containing two acres, more or less, twelve miles south of Greenville City in the northeast fork of the Georgia and Fork Shoals roads, being a part of the Huff Estate given to S. B. Huff bounded by the lands of S. B. Huff on north and west and south by Georgia road on east by Fork Shoals road and more fully described as follows: Beginning on an iron pin in Cross road 3xnm and running thence with Fork Shoals road N. 28.50 W. 11.10 chains to iron pin in said road 3xnm thence S. 62 W. 9.00 to stone 37 N.M. Thence S. 23.50 E. 11.10 to pin on bank of Georgia road thence with said road N. 62 E. 9.00 to the beginning corner and containing two acres.
