KNOW ALL MEN BY THESE PRESENTS, That I, E.D. Green

in the State aforesaid
in consideration of the sum of Six hundred and twenty-five DOLLARS,
to me in hand paid at and before the sealing of these presents by

S.E. Nobles, (the receipt whereof
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

S.E. Nobles all that piece, parcel or lot of land situate, lying and being in the State and County
aforesaid, and having the following metes and bounds: Beginning at a point on Morrow Street, B.M.
Dillard's corner and runs thence S. 78-3/4 E. 180 feet; thence at right angles 90 feet to
Dobbin's line; thence N. 78-3/4 W. 180 feet to said street; thence along said Street 90 feet to
the beginning corner, being known as lot No. 7 and part of lot No. 6 on a plat of land called
Brookville.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.
