KNOW ALL MEN BY THESE PRESENTS, That I, Henry P. McGee, of Greenville

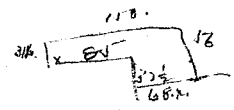
in the State aforesaid

in consideration of the sum of Four hundred & ninety-three and 61/100 DOLLARS,

to me in hand paid at and before the sealing of these presents by J.S. Hunter

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.S. Hunter, All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County and State aforesaid, Beginning at an iron pin on said Hunters corner, thence N. 75 E. 85 feet to an iron pin on said Hunters corner, thence S. 13-1/2 E. 32-1/2 feet to iron pin, thence N. 80 E. 68 feet 4 inches to iron pin, thence N. 21-1/4 West 56 feet to iron pin, thence S. 80-1/4 W. 150 feet to iron pin on McGee St., thence S. 21-1/2 E. 31-6/10 feet on McGee St. to the beginning corner, this boundary includes certain strips of land heretofore conveyed to said Hunter by said McGee.



TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
