KNOW ALL MEN BY THESE PRESENTS, That We, A. J. Vaughan, Sallie Burdett and May Vaughan of Greenville County.

in the State aforesaid in consideration of the sum of Five hundred fifty (\$550.00) DOLLARS, to us in hand paid at and before the sealing of these presents by Susan Vaughan

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Susan Vaughan, all that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, having the following metes and bounds to wit: Beginning at a stone on the North side of the Chick Springs Road and running thence N. 17 E. 150 feet to an iron spike NM, thence S. 83-1/2 E. 80 feet to a stake NM, H.L. Riley corner; thence S. 17 W. 150 feet to Chick Springs Road; thence with said Road N. 83-1/2 W. 80 feet to the beginning corner, containing twelve thousand (12,000) square feet more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Susan Vaughan, and her heirs and assigns forever.
