Lizzie Cooksey, All that certain piece, parcel or lot of land, situate, lying and being in Fourth Ward of the City of Greenville, County of Greenville, State aforesaid, having a frontage on Falls St. of fifty seven feet and running East, one hundred feet, containing five thousand seven hundred square feet, more or less. A part of this lot is the same heretofore conveyed to B.W. Holland by A.A. Foster by deed bearing date Oct. 7th, 1887 and more fully described in R.M.C. office Vol. T.T. page 406 and the other part of this lot is the same heretofore conveyed to B.W.
