

W.C. McDaniel DEED TO W.D. Sitton THE STATE OF SOUTH CAROLINA, COUNTY OF Greenville

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, W.C. McDaniel in the State aforesaid in consideration of the sum of Five dollars and other valuable considerations

to me in hand paid at and before the sealing of these presents by W.D. Sitton (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said W.D. Sitton, his heirs and assigns, All that tract of land situate in the State and

County aforesaid, on head waters of South Pacolet River, containing twenty (20) acres, more or less: Beginning at a stake at branch; thence up the branch to a chestnut oak; thence nearly south a conditional line to a rock at road; thence eastward with said road to a chestnut oak; thence nearly north to the beginning corner, being the same land conveyed to me by Mary Ballew, formerly Mary E. Anders, by deed dated the 15th, day of November 1917 and recorded in Vol. 46 page 573.

Also that other piece, of land situate on waters of South Pacolet River, in the State and County aforesaid: Beginning at a rock on the road leading to Mountain Hill Church, and runs thence nearly North to a chestnut oak near the branch; thence up the branch to the Spring branch; thence up spring branch to the road; thence with said Road to beginning corner, adjoining tract of land conveyed to the said Mary Ballew as above described. Being the same land conveyed to me by F.D. Ballew, the -- day of November 1917 and recorded in Vol. 46, Page 572.

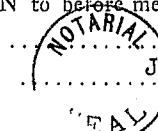
