Curry, All that lot or parcel of land lying and being and situate in the Town of Simpsonville, County and State aforesaid and having the following metes and bounds, to-wit: Beginning on a rock corner on Old Stage road and running thence two hundred and forty-six (246) feet in a westerly direction to a rock on W.T.
