NOW, KNOW ALL MEN BY THESE PRESENTS, That *Louise M. Williams* of the City and County of *Greenville* in the State aforesaid in consideration of the sum of *Two Thousand* DOLLARS, to *me* in hand paid at and before the sealing of these presents by *L. A. Dinsley*

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

L. A. Dinsley, all that piece parcel or lot of land situate lying and being on *Warlington Street* in the City of *Greenville*, County and State aforesaid and being known as lot "B"; said lot "B" beginning at a stake on *Warlington St.* corner of lot "A" and running thence *N 28 3/4 E* one hundred and sixteen feet to stake, thence *S 71 3/4 E* thirty three feet seven and one half inches to the fence corner of *Mrs. M. Bee's* line (lot) thence with said *M. Bee's* line *S 30 1/2 W* one hundred and seventeen ft. and two inches to *Warlington Street*, thence with *Warlington St.* *N 69 W* thirty feet to the beginning corner. Said lot "B" being on a plat prepared by *S. W. Rodgers*, Surveyor giving the meters and bounds above being the same lot of land conveyed to me by *Suther M.
