(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
Amanda E. Roe, All that certain piece, parcel or tract of  
land situate, lying and being in Oreal township County  
of Greenville a/cd State of So. Car. on branch waters  
of South Tyger river, bounded by lands of Jas. F. Howell  
W. W. Atkin D. L. Ray and Washington Church and  
Washington School containing twenty-nine (29) acres be  
the same more or less, same being part of the  
John Cox land.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.  
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Amanda E. Roe, her
