 NOW, KNOW ALL MEN BY THESE PRESENTS, That W. E. Chapman and T. P. Chapman
 in the State aforesaid,
 in consideration of the sum of Fifteen Hundred DOLLARS,
 to us in hand paid at and before the sealing of these presents by Lucy L. Hindman

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Lucy L. Hindman, all that certain piece, parcel and tract of land situate, lying and being in the State of South Carolina, Greenville County, Plumkin Township, and on the mountain creek waters of Saluda River: Beginning at a stone 3x, on the aforesaid creek, the mouth of a branch, thence up the meanderings of the said branch and follow to a stone 3x, pine 3x gone; thence due north 14.00 chains to a stone 3x; thence S. 80 W. 29.00 chains to a stone 3x; thence S. 23 E. 21.00 chains to a stone 3x; thence S. 89 E. 37.00 chains to a stone 3x, on the aforesaid creek; thence up the meanderings of said creek to the beginning corner containing sixty-nine acres, more or less, and being the same tract of land conveyed to us by E. Inman, Master, by deed dated September 22nd, 1915, recorded in R. M. C. office for Greenville County in Vol. 14, page 245.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Lucy L. Hindman her heirs and assigns, forever.

AND we do hereby bind ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Lucy L. Hindman her heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
