County aforesaid
 (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

E. W. Painter his heir and assigns, all of that certain
piece, parcel, and lot of land, situated in Greenville
County and State aforesaid, adjoining lands of Robt.
Smith, Moll Jones, J. M. Hudson and others, being the
same land conveyed to me by Bessie Vaughn, and
